

SALTSHAKER BVI TERMS OF SERVICE

By booking with Salt Shaker BVI, I agree to the terms of service.

Additional

1. Additional, individual fishing licenses required (\$60 each, additional cost) for every adult angler 18yrs and older. Passport copies required for each angler 2 weeks prior to the fishing charter rentals or immediately upon Booking.
2. Additional cruising permits (\$5 per person additional cost) are also required for BVI customs.
3. Additional 7% added to total cost when paying via credit/debit card. This is calculated by dividing the total cost by 0.93 (93%).
4. USVI transfers subject to customs and immigration hours of operation and international processing fees.
5. Additional fuel surcharge may apply to certain pickup and drop-off locations (Jost Van Dyke, Anegada, Cane Garden Bay, Brewers Bay, Sopers Hole, etc).

Inclusions

Charter rate includes services of captain and crew, fuel, snorkelling equipment, noodles, tackle, bait, soft drinks & 12pack beer included. Gratuity NOT included. All associated permits and fees are covered by Salt Shaker BVI. All charters are PRIVATE, no shared charters. We do not book multiple parties on same charters unless prior arranged with Salt Shaker BVI. If fishing anglers are collectively permitted to keep up to 30lbs of fish per charter and can purchase additional fish at market price.

Cancellation

Cancellations made more than 7 days before original scheduled charter will receive a refund of any charter deposit already paid, minus any fees or costs incurred to the business (such gov license and permit fees). Deposits for cancellations made less than 7 days are non-refundable. If you fail to contact Salt Shaker BVI within 72 hours of your original scheduled departure time and/or fail to show up, the entire charter rate will be billed to your credit card on file.

Payment

A 100% payment of the full charter price/rate is due upon booking to secure a charter date. We book on a first-come-first-serve basis. Payment can be made by cash, check, wire, ach bank transfer or credit/debit card. Full and complete settlement of funds for check, wire and bank transfer are required to consider a charter booked and confirmed.

Gratuities

The crew at Salt Shaker BVI are professionals, and their goal is to always ensure you have an amazing day on the water. Gratuities offered for exceptional service are always appreciated, and generally average between 10-20% of the total charter cost.

Liability

I, the undersigned, in consideration of the service of Salt Shaker BVI, its officers, employees, contractors, agents or representatives, hereby agree to release and hold harmless Salt Shaker BVI on behalf of myself, my heirs, assigns, personal representative and estate as follows: I understand and acknowledge that the activity I am about to voluntarily engage in as a participant bears certain known risks and unanticipated risks which could result in injury, death, illness or disease, physical or mental damage, or damage to myself, to my property, or to spectators or other third parties.

The following describes some, but not all of those risks. Risks include, but are not limited to: death, drowning, bodily injury, sunburn, dehydration, insect or animal bites, encounters with wildlife, and other harm which may be encountered in participating in wading, boating, guided and unguided fishing, and those activities associated therewith. I expressly agree, and promise to accept and assume all responsibilities and risk of injury, death, illness or disease, or damage to myself, to others, or to my property, arising from my participation in this activity. In signing this document I fully recognize that if anyone is hurt or property is damaged while I engage in this event, I will have no right to make claim or file a lawsuit against Salt Shaker BVI or its officers, agents, contractors, or employees.

PHYSICAL HEALTH: To the best of my knowledge I, the client, have no physical restrictions which would prohibit my participation in any-and-all activities offered by Salt Shaker BVI, including fishing, boating, boarding or disembarking the vessel, or consuming food or beverage prepared by the outfitter or their representatives. I certify that I have sufficient health, accident, and liability insurance to cover any bodily injury or property damage I may incur while participating in this event and to cover bodily injury or property damage caused to a third party as a result of my participation in this event. If I have no insurance, I certify that I am capable of personally paying for any and all such expenses or liabilities. Should emergency medical services become necessary to me or any minor I have authorized to participate, I agree that I will not hold Salt Shaker BVI liable regarding the provision of medical and/or emergency care or the adequacy of any such care. Salt Shaker BVI reserves the right to decline service to any person it judges incapable of meeting the requirements of participating in fishing related activities.

RELEASE & ACKNOWLEDGEMENT OF RISK: I understand and acknowledge that the activity I am about to voluntarily engage in as a participant bears certain known and unanticipated risks as described in this document. I expressly agree, and promise to accept and assume all responsibilities of all risks while I engage in this event, and agree that I will have no right to make claim or file a lawsuit against Salt Shaker BVI, or its officers, contractors, agents, or employees. By signing this Agreement I, myself, or as parent or guardian of any accompanying minor, unconditionally release and hold harmless Salt Shaker BVI and/or their representatives against and for all liability, cost, expenses, claims and damages for which the guide might otherwise become liable by reason of any accident, illness or injuries to, or death of, any persons, or damage to property or both, in any manner arising or resulting from, caused by, connected with or related to the participation in any activity or service offered by Salt Shaker BVI, regardless of how, where, or when such injury, illness, death or damage occurs even if caused by the negligence of the guide, its agent, contractor, or employees, or due to conditions, defects in the vessel, equipment or activities.

I agree and acknowledge that I have read and fully understand the contents of this entire document, understand that it affects my legal rights, and agree to be bound by its terms. I, the client, understand all its terms and that it shall be effective and

binding upon myself, my respective heirs, successors and assigns. I execute it voluntarily with full knowledge of its significance.
